By signing this form, the parent or guardian agrees to assume and accept all risks and hazards inherent in church-related social activities. They also agree not to hold Gretna United Methodist Church, its leaders, employees, and volunteer staff liable for damages, losses, diseases, or injuries incurred by the subject of this form.

MEDICAL RELEASE

LOCK-IN RULES

- All youth must sign this sheet, indicating their agreement to these rules.
- During lock-Ins, all youth must remain within the church. No unauthorized exiting or entering will occur.
- It is expected that all lock-in participants (youth and adults) will participate in the program.
- Be considerate and respectful of other participants and leaders.
- Be respectful of the church and property of the church.
- Violation of these rules will result in disciplinary action and may include the participant being asked to leave the lock-in. Parents will be called to pick them up regardless of the hour.
- The first infraction will result in a verbal warning. Repeated violations will result in calling the parent to pick the youth up.
- THE ENFORCEMENT OF THESE LOCK-IN RULES IS EVERYONE'S RESPONSIBILITY.
